CITY OF LIGHTS CELEBRATES 40 YEARS OF NETS TUNE IN MONDAY SEPTEMBER 12TH AT 8:30PM

The 10 Meter SSB frequency is 28.720 MHz



The City of Lights Chapter of <u>Ten-Ten International</u> was started on Monday (CST), November 8, 1976 by members of the Aurora, Illinois local ham radio club, <u>The Fox River Radio League</u> (FRRL). Aurora Illinois was the first city to have electric street lights, which led to its slogan and our chapter name, "The City of Lights." The Monday night nets have continued in an unbroken string to date. The SSB net started on 28.70 MHz, but soon after, moved to 28.720 MHz, where it remains today.

The first Net Control and Chapter Head was Jerry Frieders, W9ZGP (SK) 10-10 #12847. In mid-1995, and then in ill health, Jerry turned the Net over to Joe Dubeck, NA9A, 10-10 #31121. Joe remains the Chapter Head and is usually Net Control for the SSB nets.

Other nets were added at different times. In the 90s, an SSB "Early Net" ran for quite a while at 28.430 MHz (7:30 PM CST) headed up by Ron Kennedy N9KBJ, 10-10 #58638. That net went QRT when Ron moved to California.

Also in the 90s, the City of Lights CW Net was started at 28.280 MHz by Lee Fenton, WS9F (SK), 10-10 #60236. When Lee suddenly passed away, the CW net was taken over by Bill Schaben, WA9AUW (now W9AX) 10-10 #62915. When Bill's time was restricted by evening work commitments, Robert "Benny" Benson, W9CZA, 10-10 #62970 stepped up to the key and moved the CW Net to 28.150 MHz - where it remains to-day. In April, 2009, Benny's health forced his retirement as the CW Net Control (*W9CZA SK 10/24/10*) and the CW net is now run by Kermit Carlson, W9XA, 10-10 #73844.

About the FRRL

The Fox River Radio League, Inc., is a general interest amateur radio club serving the central Fox River Valley area. Records indicate the club has been in existence since at least 1924, and has functioned continuously ever since. We are an ARRL Special Service Club, an Illinois not-for-profit corporation, and a 501(c)(3) tax exempt organization as specified in Federal IRS Statutes. We sponsor training classes for new hams, license examination sessions, an annual hamfest, and participate in various public service events. If you have a specialized amateur radio interest, chances are you can share it with one or more of our club members.

The Fox River Radio League meets on the 2nd Tuesday of every month at Bethany Lutheran Church at 8 S. Lincoln St in Batavia... The meeting begins at 7:30 PM and includes a business portion, social time and a program of interest.

Bill Erikson HF Challenge

As summer winds down, interest in getting on the air seems to be rising, at least among Challenge participants. We learned of some interesting catches as well as some upcoming events that members might want to pursue.

Larry K9ARZ reported that despite continuing difficult band conditions, we're beginning to see some openings. His recent catches include Mali, Western Sahara, Saudi Arabia, Market Reef, Guam, Thailand, New Zealand, Macedonia, Tuvalu and an assortment of others. "It will be nice to get out of the summer doldrums," he commented.

Cedric WT2P commented that most of his contacts reported this month came during NAQP contests during the summer. "Band conditions from this humble station continue to be challenging, even with 1KW," he said. "Highlight was getting CY9C on 5 band/ mode slots as well as a lot of European countries in the Worked All Europe contest."

Challenge Administrator Joe NA9A shared some good news. He made a contact with YV0 for an all-time new CW country! Joe also offered information on upcoming opportunities for those interested in rare DX, including the Bird Island station. "For the first time in almost ten years, YV0* Aves Island (Bird Island), IOTA NA-020 is on the air," Joe explained. "After an uncertain approval from the Venezuelan Navy, they started 8/28 UTC and plan to be operating for 7 to 10 days. Aves Island is #30 on Mid America's most wanted list and being in the Caribbean only 2400 miles away, it might be workable on all HF bands plus 6 meters. They were very loud on 8/28 0200 Z at 10.107 MHz.

"Then on Sept. 8-17, another asterisked country and #25 on Mid America's most wanted list will be on. A5A* in Bhutan will be running 3.5 through 28 MHz working SSB, CW and RTTY. When over, they will have a OQRS activated on Club Log or by direct mail. If you haven't tried OQRS yet, you'll find it much faster and cheaper to get a QSL card and LOTW confirmation than by using direct mail. Check out OQRS at Club Log: <u>https://secure.clublog.org/loginform.php</u>."

Your scores should include all contacts from Jan. 1st through Sept. 15th.
